## **Preface**

From 'All characters in this movie are fictitious' to 'This is based on real-life incidents' - every time you sit down to watch something, it usually starts with few Disclaimers. Use of Disclaimers have become very common, it is everywhere, and sometimes we do not even pay heed to it. The question is what legal value does these disclaimers serve? Why does every movie more or less repeat the same disclaimer? What purpose does a disclaimer solve?

Let us find out.



## UNDERSTANDING 'DISCLAIMERS' IN THE WORLD OF MOVIES

Disclaimer, according to Cambridge Dictionary, means a formal statement declaring that the person is not legally responsible for any information on the internet, or in simple terms that you are not directly involved in it.<sup>1</sup>

In legal terms, a disclaimer *is a defensive measure, used generally with the purpose of protection from unwanted claims or liability*.<sup>2</sup> It is generally used as a defense where a person limits the scope of rights and obligations that might be enforced by anyone, wherein both of them are legally connected.

Thus, disclaimers are a type of tool in the hands of people and their businesses that protect them from any legal action by either displaying it on the screen or in the form of "terms of service". Thus, their work or business remains protected.<sup>3</sup>

Today, disclaimers have become a part of the creative process of making a film. During the process of making the film, different kinds of issues are identified, and then Disclaimers are innovatively crafted within the film to reduce the possibility of legal action from any person who believes that he or she has been wronged via some portrayal in the work.

## WHY INCLUDE DISCLAIMERS?

A 1932 lawsuit against MGM Studios for 'Rasputin and the Empress' can be credited for starting the practice of Disclaimers in movies. The movie was about "Grigori Rasputin, the famously hard-to-assassinate Russian mystic and intimate of the last, doomed Romanovs." One of the reasons for the lawsuit was that the movie in its disclaimer that specified that some characters in the movie were still alive, and also, they gave enough indications to find who these people were. The film began with a claim that "This concerns the destruction of an empire ... A few of the characters are still alive—the rest met death by violence." Reportedly, a justice in the case told MGM that the studio might have stood a better chance had they incorporated a disclaimer stating the exact opposite: that the film was not intended as an accurate portrayal of real people or events.

Rasputin and the Emperor set the ball rolling towards inclusion of Disclaimers. Since then, the movie world started putting disclaimers with intent to:

#### 1. OMG - Oh My God!


#### DISCLAIMER

The 2012 Bollywood movie OMG! Oh My God! took a step ahead and included a special disclaimer that explained the theme of the movie. The movie was a satirical comedy wherein the protagonist sues God. To avoid hurting any religious sentiments, the Censor Board advised the makers include such a disclaimer.

### 2. Chakravyuh



Chakravyuh, a 2012 released movie, had a song Mehangai which included lyrics i.e. 'Birla ho ya Tata, Ambani ho ya Bata, Sabne apne chakkar mein des ko hai kaata'. This led to Bata moving to the Supreme Court alleging the song is defamatory. While SC refused to stop


the song, it advised the makers to add a disclaimer to the song, saying, "Use of the names of the song are merely as example. No injury or disrespect is intended to any particular person or brand."

#### 3. JODHA AKBAR



When Hrithik Roshan and Aishwarya Rai starrer Jodha Akbar was hit with controversy regarding the female protagonist, the disclaimer at the beginning of the movie shielded it. The controversy was related to the name of the female protagonist i.e. Rani Jodha Bai. However, the response to the protest was at the beginning of the movie which clarified that there was historical evidence of character however different historians named her differently, the particular name was chosen in the movie based on its popularity amongst all.

#### 4. ROBOT 2.0

Just before the release of the movie Robot 2.0 in 2018, the makers were slapped with a legal notice by the Cellular Operators Association of India (COAI). It was alleged that the

movie had 'obscurantist and anti-scientific attitudes towards mobile phone, towers and mobile services'. However, the disclaimer again came to the film's rescue. It elucidated that the movie was based on newspaper and digital media articles.

These stereotypes were wrong then and are wrong now. # REGULATION OF DISCLAIMERS IN INDIA

Central Board of Film Certification (CBFC), under the guidance of the Government of India and the Ministry of Information and Broadcasting, is mainly a statutory body that is entrusted with the task to provide a certificate to films and movies. The body is entrusted with the function to standardize the films and movies and decide whether they are fit to go public or not as per the provisions of the Cinematograph Act, 1952. The officers of the CBFC are of the view that they do not mandatorily ask for the film producers to have disclaimers without them watching that particular film. They believe that disclaimers are required only when a film has something related to historical, research-based, non-fiction. The disclaimers such as merely stating, that "inspired by true events" are not acceptable by them and it depends upon case to case. Central Board of Film Certification (CBFC), under the guidance of the Government of India and the Ministry of Information and Broadcasting, is mainly a statutory body that is entrusted with the task to provide a certificate to films and movies. The body is entrusted with the function to standardize the films and movies and decide whether they are fit to go public or not as per the provisions of the Cinematograph Act, 1952.9 The officers of the CBFC are of the view that they do not mandatorily ask for the film producers to have disclaimers without them watching that particular film. They believe that disclaimers are required only when a film has something related to historical, research-based, non-fiction. The disclaimers such as merely stating, that "inspired by true events" are not acceptable by them and it depends upon case to case.10

Further, the Ministry of Information and Broadcasting believes that a movie can have two three disclaimers also, depending upon the theme or the subject matter of the movie. Further, in the year 2016, I&B released a notice to the filmmakers that in cases where rash driving scenes are there, they are required to mandatorily show disclaimers so that the general public does not violate any traffic rules.

Now, the health disclaimers such as that of anti-tobacco are controlled by The Cigarettes and Other Tobacco Products (Prohibition of Advertisements and Regulation of trade and

commerce, production, supply and distribution) Act, 2003.<sup>11</sup> The rules framed under the act in the year 2004, which later amended in the year 2005 and 2012<sup>12</sup>, lays down that every movie, show, or any television program showcasing any kind of tobacco products are to mandatorily display "anti-tobacco health spots of a minimum of 30 seconds duration either in the beginning or in the middle of the show."

Additionally, the Advertising Standards Council of India (ASCI) is the self-regulatory authority that legalizes disclaimers to be added in ads displayed on the television. To help customers better understand their rights and not get misled, recently in the year 2018, it released a comprehensive set of guidelines for getting a better understanding of disclaimers that are used during advertisements in India. (It includes within it "hoardings" also).
